Prevent formation of aerosols. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid splashes or spray in enclosed areas. Avoid contact with eyes, skin, and clothing. Conditions for safe storage, including any incompatibilities:

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly closed. Protect from freezing.

SECTION 8: Exposure controls/personal protection**Control parameters:**

Appropriate engineering controls: Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
