Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen. Give artificial respiration if necessary.

**After skin contact:**

Wash affected area with soap and water. Rinse/flush exposed skin gently using water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

**After eye contact:**

Protect unexposed eye. Remove contact lens(es) if able to do so during rinsing. Immediately flush eyes for 15 minutes. Immediately get medical assistance.

**After swallowing:**

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air. Collect solids in powder form using vacuum with HEPA filter. Provide ventilation.

**Reference to other sections:** None**SECTION 7: Handling and storage****Precautions for safe handling:**

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air. Avoid ingestion and inhalation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid generation of dust or fine particulate. Avoid contact with skin, eyes and clothing.

**Conditions for safe storage, including any incompatibilities:**

Store in a cool location. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly closed. Store with like hazards.
