Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing is difficult give oxygen. Give artificial respiration if needed.

After skin contact:

Appropriate engineering controls: Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use or handling.
