SECTION 4: First aid measures**Description of first aid measures****After inhalation:**

Wear protective equipment. Transfer to a disposal or recovery container. Use respiratory protective device against the effects of fumes/dust/aerosol. Ensure adequate ventilation.

Methods and material for containment and cleaning up:

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Place into properly labeled containers for recovery or disposal. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air. Collect solids in powder form using vacuum with HEPA filter.
