**SECTION 4: First aid measures****Description of first aid measures****After inhalation:**

Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. If breathing difficult, give oxygen. Do not give mouth-to-mouth resuscitation. Give artificial respiration if necessary. Seek medical assistance.

**After skin contact:**

Wash affected area with soap and water. Rinse/flush exposed skin gently using water for 15-20 minutes. Get medical attention immediately.

Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. Avoid generating dust; fine dust dispersed in air in sufficient concentrations, and in the presence of an ignition source is a potential dust explosion hazard. Hydrogen chloride gas, Iron oxides.

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air. Minimize dust generation. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials.
