**SECTION 4: First aid measures****Description of first aid measures****After inhalation:**

Prevent formation of aerosols. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid splashes or spray in enclosed areas. Wash hands after handling.
