SECTION 4: First aid measures**Description of first aid measures****After inhalation:**

SECTION 6: Accidental release measures**Personal precautions, protective equipment and emergency procedures:**

Wear protective equipment. Transfer to a disposal or recovery container. Avoid contact with eyes, skin, and clothing. Use spark-proof tools and explosion-proof equipment. Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid generation of dust or fine particulate. Avoid contact with skin, eyes and clothing.
