Minimize dust generation and accumulation. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas. Avoid contact with skin, eyes and clothing. Wash hands after handling.

Product is sensitive to light. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store away from foodstuffs. Store away from oxidizing agents. Store in cool, dry conditions in well sealed containers. Keep container tightly closed. Store with like hazards.
