Minimize dust generation and accumulation. Follow good hygiene procedures when handling chemical materials. Refer to Section 8. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with skin, eyes and clothing.

Conditions for safe storage, including any incompatibilities:

Store away from incompatible materials. Protect from freezing and physical damage. Keep away from food and beverages. Store away from Oxidizing agents and strong bases. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store in cool, dry conditions in well sealed containers. Store with like hazards.

Appropriate engineering controls: Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
