Store in a cool location. Keep away from food and beverages. Protect from freezing and physical damage. Provide ventilation for containers. Keep container tightly sealed. Store away from incompatible materials.

#### Control parameters:

**Appropriate engineering controls:** Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use or handling.
