Prevent formation of aerosols. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Control parameters:

Appropriate engineering controls: Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
