SECTION 4: First aid measures**Description of first aid measures****After inhalation:**

Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Always obey local regulations. Refer to Section 8.
