SECTION 4: First aid measures**Description of first aid measures****After inhalation:**

Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

After skin contact:

Wear protective equipment. Use spark-proof tools and explosion-proof equipment. Ensure that air-handling systems are operational. Ensure adequate ventilation.

Environmental precautions:

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13. Should not be released into environment.

Methods and material for containment and cleaning up:

Keep in suitable closed containers for disposal. Wear protective eyewear, gloves, and clothing. Always obey local regulations. Refer to Section 8. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. Avoid dispersal of dust in the air. Collect solids in powder form using vacuum with HEPA filter. Evacuate personnel to safe areas.

SECTION 7: Handling and storage**Precautions for safe handling:**

Minimize dust generation and accumulation. Follow good hygiene procedures when handling chemical materials. Refer to Section 8. Wash hands after handling. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with skin, eyes and clothing.

Conditions for safe storage, including any incompatibilities:

Store away from incompatible materials. Protect from freezing and physical damage. Keep away from food and beverages. Protect from light. Do not store with acids. Provide ventilation for containers. Avoid storage near extreme heat, ignition sources or open flame. Store in cool, dry conditions in well sealed containers. Store with like hazards.

SECTION 8: Exposure controls/personal protection**Control parameters:**

Appropriate engineering controls: Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling. Provide exhaust ventilation or other engineering controls to keep the airborne concentrations of vapor or dusts (total/respirable) below the applicable workplace exposure limits (Occupational Exposure Limits-OELs) indicated above.
