Loosen clothing as necessary and position individual in a comfortable position. Move exposed to fresh air. Give artificial respiration if necessary. If breathing is difficult give oxygen. Get medical assistance if cough or other symptoms appear.

**After skin contact:**

Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

**After eye contact:**

Protect unexposed eye. Rinse/flush exposed eye(s) gently using water for 15-20 minutes. Remove contact lens(es) if able to do so during rinsing. Seek medical attention if irritation persists or if concerned. Do NOT allow victim to rub eyes or keep eyes closed.

**After swallowing:**

Rinse mouth thoroughly. Do not induce vomiting. Have exposed individual drink sips of water. Seek medical attention if irritation, discomfort or vomiting persists. Due to delayed and persistent symptoms, observe patient closely for 48 hrs. Treat symptomatically.
