Combustion products may include carbon oxides or other toxic vapors. Thermal decomposition can lead to release of irritating gases and vapors. **Methods and material for containment and cleaning up:**

can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. **Appropriate engineering controls:** Emergency eye wash fountains and safety showers should be available in the immediate vicinity of use/handling.
