Rinse/flush exposed skin gently using soap and water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

SECTION 7: Handling and storage**Precautions for safe handling:**

Minimize dust generation and accumulation. Follow good hygiene procedures when handling chemical materials. Refer to Section 8. Remove contaminated clothing and wash before reuse. Avoid contact with clothing and other combustible materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Avoid contact with skin, eyes and clothing.

Store away from incompatible materials. Protect from freezing and physical damage. Keep away from food and beverages. Provide ventilation for containers. Appropriate engineering controls:
