**SECTION 7: Handling and storage****Precautions for safe handling:**

Minimize dust generation and accumulation. Wash hands after handling. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances.
