**SECTION 4: First aid measures****Description of first aid measures****After inhalation:**

Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. If breathing difficult, give oxygen. If not breathing, give artificial respiration. Do not give mouth-to-mouth resuscitation. Get medical aid.

**After skin contact:**

Get medical aid. Flush skin with plenty of water for at least 15 minutes while removing contaminated clothing and shoes. Wash clothing before reuse. Wash affected area with soap and water. Rinse/flush exposed skin gently using water for 15-20 minutes. Seek medical advice if discomfort or irritation persists.

**After eye contact:**

Avoid dispersal of dust in the air. Avoid contact with skin, eyes and clothing. Wash hands after handling. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. Use only in well ventilated areas.

**Conditions for safe storage, including any incompatibilities:**

Protect from freezing and physical damage. Store in tightly closed container under an inert atmosphere. Provide ventilation for containers.
