SECTION 4: First aid measures**Description of first aid measures****After inhalation:**

Move exposed individual to fresh air. Loosen clothing as necessary and position individual in a comfortable position. Seek medical advice if discomfort or irritation persists. If breathing difficult, give oxygen.

After skin contact:

Wear protective equipment. Transfer to a disposal or recovery container. Use spark-proof tools and explosion-proof equipment. Use respiratory protective device against the effects of fumes/dust/aerosol. Keep unprotected persons away. Ensure adequate ventilation. Keep away from ignition sources. Protect from heat. Stop the spill, if possible. Contain spilled material by diking or using inert absorbent.

Environmental precautions:

Prevent from reaching drains, sewer or waterway. Collect contaminated soil for characterization per Section 13.

Methods and material for containment and cleaning up:

If in a laboratory setting, follow Chemical Hygiene Plan procedures. Collect liquids using vacuum or by use of absorbents. Place into properly labeled containers for recovery or disposal. If necessary, use trained response staff/contractor. Dust deposits should not be allowed to accumulate on surfaces, as these may form an explosive mixture if they are released into the atmosphere in sufficient concentration. SECTION 7: Handling and storage**Precautions for safe handling:**

Minimize dust generation and accumulation. Wash hands after handling. Avoid dispersal of dust in the air. Use only under a chemical fume hood. Routine housekeeping should be instituted to ensure that dusts do not accumulate on surfaces. Dry powders can build static electricity charges when subjected to the friction of transfer and mixing operations. Follow good hygiene procedures when handling chemical materials. Do not eat, drink, smoke, or use personal products when handling chemical substances. If in a laboratory setting, follow Chemical Hygiene Plan. Use only in well ventilated areas. Avoid generation of dust or fine particulate. Avoid contact with skin, eyes and clothing.
